How to make a Section 12 Declaration

This guide is on how to make a S12 declaration for a vessel in the Coastal Trading Licensing System (CTLS). Information about S12 declarations can be found here.

This guide is representative only and does not replace the legislation. Please refer to the *Coastal Trading (Revitalising Australian Shipping) Act 2012* (the Act) to confirm legislative requirements.

Overview:

A section 12 declaration allows a vessel to perform intrastate voyages under the Act.

Important:

- Section 12 declarations are not licences.
- Intrastate voyages can be performed under state/territory regulations.
- A section 12 declaration is required for a vessel performing an <u>intrastate</u> voyage when a temporary licence holder <u>chooses</u> to perform the voyage under the Act.
- If a voyage is to be performed under state/territory regulations, the vessel performing the voyage does <u>not</u> need to be declared under section 12, and the voyage does not have to be authorised on a temporary licence.
- The Shipping Business Unit (SBU) cannot advise on state/territory regulations, as we do not administer them.

Who can apply?

Only an <u>owner</u> of a vessel can apply for a section 12 declaration. Section 6 of the Act defines an owner of a vessel as one or more of the following:

- (a) A person who has a legal or beneficial interest in the vessel, other than as a mortgagee;
- (b) A person with overall general control and management of the vessel;
- (c) A person who has assumed responsibility for the vessel from a person referred to in paragraph (a) or (b).

You do not have to be a holder of a temporary licence, general licence or a transitional general licence holder to apply for a section 12 declaration for a vessel. Information on how to register in CTLS can be found here:

Supporting Documentation

The Delegate may on occasion request documentation outlining how you meet the definition of an owner.

Your supporting document(s) should clearly show how your organisation meets the criteria as an owner. Providing a link to a company website may not be considered sufficient evidence by the Delegate.

If you have assumed responsibility for the vessel in accordance with section 6(c) or are acting as an Agent for the owner of the vessel, your supporting documentation could be in the form of a letter from the owner addressed to the Delegate. The content of the letter should be concise in confirming your relationship with the owner of the particular vessel.

Please ensure that any letter or document contains information that clearly identifies the owner of the vessel and in what capacity the owner of the vessel has appointed you. If there are subsidiaries involved in this relationship, please be clear in the relationships between parent companies, subsidiaries and your organisation.

The Delegate should be able to clearly trace the relationship between you and the owner of the vessel.

Examples of how ownership may be ascertained by the SBU

The Shipping Business Unit (SBU) uses various databases to ascertain a ship's owner/manager/operator.

If the organisation making the application is identifiable as an owner as defined in section 6 of the Act, the SBU would not normally seek further evidence from the applicant.

If a link between the applicant and the vessel's owner is unable to be confirmed, further information would be sought.

Example 1:

Organisation XYZ applies for a section 12 declaration for a vessel.

Vessel owner/manager/operator record searches for the vessel show no link with XYZ.

XYZ will be asked to provide evidence they have the owner's consent to make the application.

Evidence may be in the form of:

- A letter/email from the owner giving consent for your application.
- A contractual agreement between owner and applicant (with sensitive information redacted)

Example 2:

Organisation XYZ makes an application and provides evidence it is making application on behalf of vessel manager ABC.

Vessel owner/manager/operator record searches for the vessel show no link with ABC.

In this case, **XYZ** would need to provide evidence that the vessel owners/managers/operators have an agreement with **ABC**, as well as show the agreement between themselves and **ABC**.

Evidence may be in the form of:

- Letters/emails.
- Contractual agreements (with sensitive information redacted).

<u>Important:</u> Any emails/letters should be from the organisation giving authorisation, not from an organisation saying they have authorisation.

Section 12 Declaration


How to apply:

1. Click on the <u>Application Forms</u> tab and then click on apply for a <u>Declaration Under Section</u> 12.





2. The "Create Section 12 Declaration" application form will open.




3. All fields must be completed and at least one of the check boxes under "Ownership Type (Please tick all that apply)" must be chosen.
If there are any details not complete when you go to submit you will see an error message.

4. When you have filled in and completed all details click Submit.

5. On clicking <u>submit</u> a pop up window with a privacy notice and declaration will appear on your screen.

Please read the declaration and choose your response.

Choosing Yes, I agree will continue with the application.

Choosing No, I disagree will take you back to the application form.

You will no longer be able make changes to your application once it has been submitted.

Failure to provide the requested information may result in the Department being unable to assess the application, or the application being refused.








6. If the application has been submitted successfully you will see a summary message like below with your application details. You will also receive a notification email.




7. Once your application has been submitted you will be able to see it on the My Applications tab and under S12 Declaration Applications. The status will change from 'Submitted' to 'Pending' when the Shipping Business Unit starts processing the application. You are able to 'Withdraw' your application on this screen at any time before the Delegate has made a decision.




